Most active regions in Europe (# of operations)




- In the second half of 2023, c.412 renewable energy deals (M&A and financing) were completed.
- The UK leads the way with c.69 deals announced, ahead of Spain and Germany with c.59 and c.51 respectively.
- In terms of volumes traded, **Spain** tops the league table with **15 GW**. Spanish renewables owner and investor **Bruc** has signed a financing agreement to raise funds for the construction of 8.5 GW of solar photovoltaic and wind power projects in Spain.
- Solar deals lead the Spanish market with c.30 transactions or financing operations against c.8 wind deals. On the other hand, the UK's market is more balanced with around 15 deals for each technology.
- Italy and France are the closest followers in terms of number of transactions and capacity traded.
- The biggest brownfield deal in terms of capacity was signed by **TotalEnergies** for the acquisition of a 25% equity stake in a **1.1-GW** Scottish offshore wind farm.
